2. A cashiers check, money order in the amount of \$144.
3. A copy of your current auto insurance card.

**Note: When requesting a driving safety course you only pay the court costs of \$144.00. Must submit request form before taking the class.**

**\*Cost is \$164.00 if in a school zone.\***

We suggest you send all correspondence to the court by certified mail.
