A RESOLUTION AUTHORIZING AND ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 2, 2026 FOR THE PURPOSE OF ELECTING THREE (3) CITY COUNCIL MEMBERS, ELECTED AT LARGE FOR A 2-YEAR TERM; DESIGNATING THE CITY SECRETARY AS THE EARLY VOTING CLERK; PROVIDING FOR EARLY VOTING; ESTABLISHING LOCATION, DAYS AND TIMES FOR EARLY VOTING TO BE CONDUCTED; DESIGNATING WHERE APPLICATIONS FOR BALLOT BY MAIL SHOULD BE MAILED AND ESTABLISHING THE LOCATION, DAY AND TIME WHERE ELECTION DAY WILL BE CONDUCTED; PROVIDING FOR THE USE OF VOTING MACHINES; PROVIDING FOR NOTICE OF SAID ELECTION; PROVIDING FOR UPDATED RULES REGARDING SUBMISSIONS TO THE U.S. DEPARTMENT OF JUSTICE; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HUBBARD, TEXAS

Section 1. The Municipal Election is hereby ordered to be held on the 2ND day of May 2026 for the purpose of electing three (3) Council Members at large for a 2-year term.

Section 2. Diana Hall, shall serve as Early Voting Clerk. Mrs. Hall's official mailing address is:

Applications for ballots by mail shall be mailed to Diana Hall at the address set out above or scanned with an original signature and email secretary@hubbardtx.gov. Regardless of method of delivery, last day to accept application by mail for a ballot to be voted by mail must be received no later than the close of business at 5:00 p.m. on Tuesday, April 20, 2026.

Section 3. Early voting by personal appearance shall be conducted beginning April 20, 2026 and continuing through April 28, 2026 at the following location in the City of Hubbard. A voter entitled to vote on early ballot by personal appearance may vote at the following location:

- (a) Main Early Voting Polling Place: Hubbard Civic Center, 300 North Magnolia Hubbard Texas
- (b) Early Voting by personal appearance shall be conducted at the above location on the following dates and times:

April 20th thru April 24th	(Monday – Friday)	8:00 a.m. – 5:00 p.m.
April 27th and 28th	(Monday-Tuesday)	8:00 a.m. – 5:00 p.m.

Section 4. Election Day Central Polling Place:

- (a) Hubbard Civic Center, 300 North Magnolia Hubbard Texas
- (b) May 2, 2026 (Saturday) 7:00 a.m. – 7:00 p.m.

Section 5. The City Secretary is directed to provide at least one accessible voting system in each polling location in accordance with Section 504 of the Federal Rehabilitation Act of 1973, the Federal Americans with Disabilities Act; and provide a practical and effective means for voters with physical disabilities to cast a secret ballot. The Office of the Texas Secretary of State has certified the Hart Verity Version 2.4 and the components of the equipment which will be provided through an agreement with Hill County Elections Office, is an accessible voting system that may be legally used in Texas elections.


Section 6. The Order of Election is the official action required by a governing body to hold an election and is signed by the governing body, (which is reflected by a vote recorded in minutes of the meeting.) The Mayor is authorized to sign the Order of Election and Notice of Election. Notice shall be posted on the city website and front door at Hubbard City Hall, used for posting of notices of meetings of the City Council not later than the twenty-first (21st) day before election day and remain posted through election day. The Notice of Election shall be published in accordance with the provisions of the Texas Election Code. Further, the Notice of Election (a separate document from the Order of Election – signed by the Mayor or Presiding Officer) is attached hereto as Exhibit "A".

Section 7. The City Secretary is no longer required or responsible for submissions to the U.S. Department of Justice for preclearance(s) in regards to elections. "Jurisdictions identified by the coverage formula in Section 4(b) of the Voting Rights Act, no longer need to seek preclearance for new voting changes, unless they are covered by a separate court order entered under Section 3(c) of the Voting Rights Act."

Section 8. Should any part, section, subsection, paragraph, sentence, clause or phrase of this Resolution be held to be unconstitutional or of no force and effect, such holding shall not affect the validity of the remaining portion of this resolution, but in all respects said remaining portion shall be and remain in full force and effect.

Section 9. That this resolution shall be effective immediately upon adoption.
